The Marsh Foundation was proud to be a sponsor of a recent collaborative training event in Mercer County. Bruce D. Perry, MD, PhD, who is well known for his clinical and basic neuroscience research. Dr. Perry's clinical research and practice has focused on high-risk children. This work has examined the cognitive, behavioral, emotional, social, and physiological effects of neglect and trauma in children, adoles-

From the Executive's desk ...

y favorite season on The Marsh Foundation Campus is spring; with school graduation, Wizard of Oz production, grass growing, trees blossoming and the flowers blooming. This is a special campus and very beautiful during this time of the year. This spring has been no different.

It has been a slow and difficult start for many of The Marsh's farmers. Planting has been delayed due to the heavy downpours of rain received in the Van Wert area. This record breaking rain in the Ohio City area has made planting difficult. The flooding in the city of Van Wert did not affect the campus of The Marsh Foundation.

Currently The Marsh
Foundation has 2,677.49 acres
of farm ground broken down
into 12 different farms with
10 different farmers. Statistics
of our farms are tracked on
a yearly and five year average
basis. These stats of corn,
wheat, soy beans and popcorn
are tracked by yields and income. Farm income accounts
for approximately 11 percent of
The Marsh Foundation income
budget.

The renovations scheduled for the summer of 2017 include the replacement of window lentils (steel I-beams located on top of the windows to support

the building's brick exterior). These steel lentils have rusted over the past 90 years and are beginning to expand. This expansion of the steel is causing the brick walls to stress crack. The Marsh Foundation Trustees continue to support the upkeep and maintenance of these special buildings.

The Marsh Foundation barns, farm maintenance, power

house, quonset and Marsh Homestead will all receive a freshen-up of paint this summer by The Marsh maintenance staff.

On December 2, 2016, The Marsh Foundation family lost Mr. Paul Wally Purmort Jr. Wally, or Grandpa Wally to the Marsh Hall boys, passed away from an extended illness. Wally was a Trustee of The Marsh Foundation from March 1987 – December 2009. Mr. Purmort will be remembered as a caring, gentle man and has been one of this organization's biggest supporters.

During Mr. Purmort's 22 years of service, he was involved in many changes and the evolution of the organization. When he became a Trustee, there were 100 youth in four homes on campus. Now, The Marsh has three group homes on campus, licensed for 10 youth each, an independent living group home, and 8, soon to be 11, licensed foster Homes

Purmort was a lifelong resident of Van Wert. He graduated from the Culver Military Academy, Miami University and the Wharton Graduate School, University of Pennsylvania. He was an Army veteran of the Korean War where he served as an aide to a General. Wally will

be greatly missed by the entire Marsh Foundation family.

The Marsh Foundation is continuing to sell brick pavers to be placed in a Memorial Patio designed for The Marsh Students and Staff. Proceeds from the brick pavers are earmarked for the construction costs, upkeep and future improvements of the area. Individuals and businesses may purchase a regular size brick paver (4" x 8") for \$100. Double size brick pavers may be purchased for \$200.

The brick pavers will be inscribed with the donor's name or business name. The brick pavers may also be purchased to honor or memorialize a loved one. One of the most meaningful things you can do in life to help a child is to become a foster parent. The Marsh Foundation celebrated Foster Care Appreciation Month throughout the month of May. The organization is consistently focused on recruiting additional families to help care for the many children in need.

To celebrate foster parents, and show our appreciation, each foster family was presented with a s'more supply kit as well as a restaurant gift card during May. The gift tag read, "We need s'more foster parents like you!"

The Marsh offers a continuum of care that includes a Foster Care Program. Last year, hundreds of children were turned away from our program because of a lack of foster homes. The Marsh believes that all children have the right to love, protection and to be cared for by a committed family.

All foster parents receive extensive training. Certified foster parents are required to undergo continuing training to maintain their license.

Dr. Perry's experience has led him to be contacted for consultation following high-profile incidents involving traumatized children such as the Columbine school shootings, the September 11th terrorist attacks and the Sandy Hook Elementary school shootings.

been instrumental in describing how childhood experiences, including neglect and traumatic stress, change the biology of the brain - and, thereby, the health of the child.

According to Marsh's clinical service's supervisor, Annette Herrmann, LISW-S, the training was a great opportunity for Marsh staff to learn more about how the brain works and how events in the lives of children impact how they behave. In addition to sponsoring the event, The Marsh had several staff members in attendance. "He spoke about how life events affect the brain and how these things manifest into behaviors," Herrmann said.

She said they took away more ways in which to work with the youth at The Marsh. "He shared tools that we can use to help kids with their coping skills, which is extremely helpful to us."

Dr. Perry's clinical research over the last ten years has been focused on integrating emerging principles of developmental neuroscience into clinical practice. This work has resulted in the development of innovative clinical practices and programs working with maltreated and traumatized children. These approaches to clinical problem solving have been integrated into the programs at dozens of large public and non-profit organizations serving at-risk children and their families.

In addition, his experience as a clinician and a researcher with traumatized children has led many community and governmental agencies to consult Dr. Perry following high-profile incidents involving traumatized children such as the Columbine school shootings, the September 11th terrorist attacks and the Sandy Hook Elementary school shootings.

"We were fortunate to have such an informative and educational opportunity so close to home," she added. CEUs were also made available for Counseling, Social Work and Teaching. Other sponsors of the event included Mercer County Job and Family Services, the Tri County Mental Health Board, Mercer County D.D., Mercer County ESC, Kip and Mary Wright and Foundations.

Closet 1:27 Connects with Marsh Foster Care Program

Closet 1:27 is an initiative operated by Woodburn Missionary Church in Woodburn, IN. The ministry provides support and supplies for Christian adoptive and foster families. They learned of The Marsh Foundation's need through one of our own foster families.

Closet 1:27 provides two main services for adoptive and foster families: foster journey bags and its resource closet. They recently delivered 28 journey bags to give to Marsh foster youth. The bags are filled according to gender and age and include things like pajamas, blankets, books, toiletries, a Bible and much more.

"We are thrilled that Closet 1:27 has reached out to The Marsh Foster Care Program," said Melissa Gearhart, foster care supervisor. "Our kids often come into care with little that belongs to them and this program gives them something that they can call their own. Plus, the items in the bags are quality, useful items that are very much appreciated by our kids and our foster parents."

According to Closet 1:27, the foster journey bags are meant to help foster children feel the love and concern of others, and introduce them to, or remind them of the love of their Heavenly Father.

The Marsh Foundation is looking forward to distributing these bags to foster children.

The Marsh is currently placing children ages 0-18 in local foster homes. Foster parents can be married couples or a

Marsh Holds Panel During Women's History Month

Earlier this spring, the cultural diversity committee at The Marsh Foundation organized two guest panels during Women's History Month. The focus was women in the workforce and featured females in traditionally male dominated fields.

The two panels featured professional women in our own community and included: Officer Brandi Dershem, Van Wert Police Department; Erin Patterson, Engineering Student; Beth Runnion, Retired School Principal; Judge Jill Leatherman, Van Wert Municipal Court; Eva Yarger, Van Wert County

Prosecutor; and Cindy Hurless; Customer Services VP, Central Insurance Companies.

Staff had the opportunity to listen to the panel answer various questions regarding their experiences in the workplace and how their gender has played a part in their career paths. In addition to pre-written questions, audience members also had a chance to ask their own. The educational opportunity received positive feedback both from staff and panel members.

Hurless, Central Insurance's Vice President of Customer Services, thought that it was a worthwhile experience that gave her the chance to share her life path with others.

"It's important for women to share their career path stories with others. Not just women but with men too. While we are similar – men and women have differences in approach and leadership styles that create solid and diverse workplaces. I think my daughters as well as my sons have benefitted from watching me pursue my professional passions," Hurless said.

She went on to say that there is now more diversity and equality in the workplace. "I think we are raising a generation of women and men that respect their peers abilities and talents – regardless of gender," she added.

Her favorite question of the day was 'can women have it all?' And, the panel's answer was a resounding 'no'!

"There are choices and priorities to contemplate and there are always trade-offs. Women spend too much time apologizing (in my opinion) for the choices we make," she concluded.
