From the executive's desk ...

Who are the children at The Marsh Foundation?

While it is impossible to speak to you specifically about every child or youth here at The Marsh Foundation, I can tell you briefly about the qualities, background, and challenges that are common to most of the children and youth we serve.

Our children, like all other children possess many qualities which they have either acquired from experiences, or have discovered once they were placed here. Some are athletic and enjoy competing in sports; many are not afraid to be assertive. They are often affectionate and eager to please adult caregivers. Artistic qualities seem to thrive among many of our children.

They are adventurous and courageous as they show an undue willingness to try new skills, or face great personal challenges. Children are resilient and posses unexpected strengths and qualities even after years of abuse, neglect, various traumas, and movement from caregiver to caregiver.

In terms of background, our children have very different histories than those of most children. Their history of neglect, abuse and inconsistent care begins early in life. They are very often placed in foster homes prior to the age of 10, with many being placed while they are yet in their primary years.

Foster home disruption is frequent and as a result, they move into more restrictive and intensive care, (group homes, residential centers, detention centers). This type of movement only serves to deepen their pain and despair.

Relationships are desperately needed by our children if they are to heal and grow but serious behavioral issues and constant movement interfere with the formulation of lasting, trusting relationships. We see them engage in a variety of destructive and self-destructive behaviors/ symptoms/coping mechanisms whose function is to try to make life bearable. As they grow older, they continue to try to develop relationships but experience a cycle of conflict, heartbreak, jealousy, violence and abandonment.

Our mission to inspire hope has become one of the overall goals of everything we do here at The Marsh Foundation. Hope, however is nonexistent without trust or faith in someone. Relationship development becomes one of the biggest challenges in a child's tenure here at The Marsh. The road to recovery and progress is long and hard but our children persist and endure. How encouraging it is to see a child who has lost all hope begin to trust again.

I am hopeful that the preceding words helped you to know a little bit more about the children and youth we serve here at The Marsh. They are very much worth our while and deserve a chance to make their lives better. Please keep them in your thoughts and prayers this season and always. Merry Christmas to everyone!

The small sign was replaced with a brick structure and a piece of limestone that alone weighed nearly two tons.

Marsh Foundation Unveils New Outdoor Sign

A long-term goal of The Marsh Foundation finally became a reality when a new sign in front of the administration building was unveiled last week. After months of planning and research by The Marsh staff and Board of Trustees, a new sign was chosen and constructed.

"We've known that the sign needed updated and it's been a long discussion," said Gerald Thatcher, trustee. In the past couple of years, The Marsh has undergone a rebranding of sorts and among other things, implemented a new logo and mission statement. "We really wanted a sign that would reflect the true vision of The Marsh Foundation," he said.

The final product was a team effort and would not have become a reality without the help of local businesses, Wellman Brothers, Inc. and Swan Memorials. "We have a long-standing relationship with Wellman Brothers and are always pleased with their professional work," said Jeff Grothouse Marsh Foundation executive secretary and treasurer. Wellman Brothers was responsible for the construction and masonry of the sign.

"We do a lot of masonry work, but this was our first actual sign," said Blair Walls, owner of Wellman Brothers, Inc. "We couldn't be happier with how it turned out."

"Swan Memorials was also fabulous to work with,"

Grothouse said. "They really worked hard to ensure that the stone was engraved and painted in a professional and timely manner. They did a great job," he said.

Connie Boley, owner of Swan Memorials, said it was an exciting community project for her team to work on. "The piece of Indiana limestone weighs 3,900 pounds and is the heaviest we've ever worked with," she said. The engraving alone took 14 hours and the paint used was mixed by hand to ensure the correct color was created.

The sign, which will

undoubtedly stand for generations to come, is a symbol of the steadfast history of The Marsh Foundation and the organization's commitment to helping children and families. Relationship Building ... One - on - One

Many times, youth that are admitted to The Marsh Foundation lack a strong, relationship with their biological family. Sometimes, they have no significant relationship with any adult. Because of this, these youth often have difficulties building and sustaining relationships.

The Marsh Foundation is very conscious of this, and in the past several years, has implemented a one-on-one program to help these youth better work their treatment. After the youth's counselor deems it appropriate, youth are paired, one-on-one, with a specific family teacher working in their home.

According to Kathleen Davis, director of residential services at The Marsh, this increases the likelihood that a youth will respond positively to treatment. "National studies, as well as our own outcomes, have shown that youth with a significant relationship in their lives are more likely to be successful in their treatment," she said. "Before they must learn how to attach to a stranger, such as a new foster parent, they are able to form a significant relationship in the group home with one adult."

The family teacher is chosen based on different criteria, such as their personality, common interests or an initial bond that is sometimes seen. It is also the goal for a family teacher to only have one, one-on-one relationship at a time.

"It can cause some difficulty with scheduling of staff," said Christy Kuhn, family teacher at Clymer Hall. Part of the one-on-one relationship requires that the staff and youth spend time together, by themselves, at least once a week, to aid with relationship building.

When deemed appropriate, The Marsh Foundation works to establish one-on-one relationships between youth and staff. The process helps youth develop better relationship building skills.

Kuhn currently has a oneon-one relationship with a girl living in Clymer Hall and she describes it as similar to a surrogate parent. "I'm there for her ups and downs," she said. "If she needs to discuss rules, or if she wants to advocate for a certain privilege, I'm the one she comes to."

She said she feels these relationships are beneficial to the youth. "This way the kids have a constant, someone that they know will care about them regardless," Kuhn said. She also said it makes the group home feel even more like a family setting.

"I'm really involved with every aspect of her treatment," Kuhn said. "I attend her treatment team meetings and we have counseling sessions together." The bond formed by these one-on-one relationships is strong. Kuhn said she sometimes gets calls on her days off, or will spend time with her youth on those days. She also still keeps in contact with a former one-on-one youth that has left the program.

Davis said she really values the family teachers who are willing to go above and beyond. "They make themselves available, even when it's not within their work schedule," she said. "They oftentimes carry that relationship beyond the youth's time here at The Marsh."

These relationships can cause staff to form a strong attachment to the youth, which isn't always easy. "It can be difficult," Kuhn admits. "With that attachment, it hurts more when they act out and it is definitely harder when they leave."

The benefits outweigh that difficulty. According to Davis, these relationships provide hope for those kids who don't have anybody to trust. "Many times our youth have lost hope and don't have anything to look forward to. This helps them realize that there is hope and it's worth looking forward to their future."

"If youth have a significant adult caring for them, they learn that they are cared about," said Davis. "This relationship means that there is one person looking after the little details in their life, it provides the role of a parent that they've never, or barely known."
